Rules and Regulations

- A. Entry fee includes the display fee, admission for the driver and admission for each legally seat-belted passenger.
- B. Clubs and groups wishing to be displayed as a group must arrive at the event together. Individual participants will not be allowed.
- C. Enter as a group through Gate 1 on the day of each event.
- D. Your group will be met with an event official at Gate 1.
- E. This Release of Liability will be signed by each display exhibitor. Entry fees will be collected from each display exhibitor. Admission wristbands and vehicle passes will be distributed to each passenger and for each vehicle. Each group will be escorted to their display area by an event official.
- F. Display vehicles should be in place on the field by 10:00am each day of the event.
- G. We encourage exhibitors to safely start their engines and show off their vehicles.
- H. For safety purposed, no vehicles may be moved once in place during the show.
- I. Display vehicles will remain on the field until 5:00pm each day of the event for spectators to view, exiting Gate 2.
